### Pre-Event Inspection

Please familiarize yourself with the PCA DE Minimum Standards found here:

Your car must be inspected by a recognized Riesentöter Safety Inspector or qualified shop prior to each and every Riesentöter event. You **MAY NOT** self inspect your own car. **Instructors MAY NOT self-inspect their cars.** Instructors are excused from Grid Tech inspection. However, a properly completed Riesentöter Region Driver Education Safety Inspection Form must be presented at each event!

**All Event Participants:** This is the only acceptable Safety Inspection Form at Riesentöter track events. No other form will be accepted. You must bring this form to both the safety inspection and the grid inspection. During event registration at the track, helmets will be inspected and must be SA certified and have the current Snell rating or 1 Snell rating prior.

**Please Note:** It is the responsibility of the vehicle owner to present a vehicle in a safe operating condition. The inspectors are not liable for the safety of this vehicle. It is the responsibility of the driver to read and adhere to all safety rules.

P F **Roll Bars/ Cages:** Mandatory for all open & semi-open cars without manufacturer's structural or deploying roll over protection; roll bars must pass the broomstick rule and must be covered with closed cell foam padding in any place where a helmet could come in contact with the bar. **Open Cars with no roof must use arm restraints.**

P F **Safety Restraints:** Factory or better installation in both seats; must be securely mounted; belts not frayed; equal restraints for passenger and driver. 4 point harnesses prohibited except Schroth Quick Fit on Schroth-approved car models only. 5-, 6- and 7-point harnesses must use seat with factory routing holes. Expiration dates adhere to SFI and FIA notification in DE Minimum Standards. Harnesses more than 5 years old must be replaced. Three point belts are not allowed with non-factory racing seats

P F **Head and Neck Restraint (HANS):** Required with harnesses.

P F **Structural Integrity:** No loose body or interior parts; no structural rust at or near suspension points.

P	F	<b>Doors:</b> Must be operational from inside and outside.
P	F	<b>Windshield:</b> No cracks in front windshield in driver's direct line of sight. Does not impair vision.
P	F	<b>Mirrors &amp; Glass:</b> Minimum of single mirror in good condition and securely mounted. All mirrors and glass must be intact
P	F	<b>Brake Lights:</b> Functioning and visible brake lights.
P	F	<b>Turn Signals:</b> For registered street cars, functioning and visible turn signals, left and right and front and back. Not required for unregistered race cars.
P	F	<b>Gas Cap:</b> In place and secure, gasket intact.
P	F	<b>Fluids:</b> NO DRIPPING LEAKS of any fluid of any type.
P	F	<b>Fluid Lines (Brake, Fuel, Coolant):</b> Routed correctly. No dry rot, cracks or leakage. Metal brake lines should not have rust or leakage. Check braided steel lines annually
P	F	<b>Battery:</b> Check for general condition of cables, corrosion, or signs of leakage. Battery should remain securely fastened when wiggled vigorously. Positive terminal covered
P	F	<b>Throttle Return:</b> Freely operating and proper spring(s).
P	F	<b>Belts:</b> Fan and other auxiliary belts in good condition with proper tension.
P	F	<b>Brakes/Clutch Pedal:</b> Brake pedal must be firm. Clutch Pedal must not bind and operate smoothly
P	F	<b>Engine Compartment / Fluids (general):</b> No excessive engine oil, coolant, or power steering fluid leaks. Hoses/ wires must be in good cond. w/ no cracks/ abrasions, and secured away from all moving parts.
P	F	<b>Date of last brake fluid flush:</b> <b>Fluid type:</b> <b>Brake Fluid:</b> Sufficient brake fluid; premium fluid recommended. Brake fluid must be changed 90 days before first event, and 180 days thereafter.
P	F	FOR PORSCHE GT PASSENGER SEATS ONLY Installation of anti-submarine belt per Section 10(h) of Minimum Standards Additional inspection must be performed to ensure there is no fraying or weakening of harness belts, especially in area of seat punch-out.
P	F	<b>Wheels – Overall Condition:</b> No cracks, bends or flaws.
P	F	<b>Wheel Bolts &amp; Lugs:</b> All nuts engaged; pay special attention to after-market wheels.
P	F	<b>Wheel Center Locks:</b> Make sure locking devices are fully engaged. <b>Caps must be removed when coming through Grid Tech</b>
P	F	<b>Tires:</b> General good condition. No cracks, cuts, cords or blisters; The tires used at the track should be teched on this form.
P	F	<b>Brake System:</b> Sufficient brake pads (3/16"/4.88mm minimum); rotors and pads are in good condition; no cuts or abrasions in brake lines. There should be no visible cracks extending to the edge of the rotor. With co-driver, pads should exceed minimum standard.

**Vehicle MUST be raised to complete the remaining inspections:**

P	F	<b>Wheel Bearings:</b> Proper free rotation; No looseness in hub.
P	F	<b>Front &amp; Rear Suspension:</b> No excessive play; ball joints and tie rods secure; boots and all seals in good condition. No leaking from shocks/struts
P	F	<b>Rear &amp; Rear Axles:</b> Check half-shaft bolts, half shaft boots in good condition; mounting hardware in good condition; no leakage.
P	F	<b>Exhaust:</b> Securely fastened and in good condition.
P	F	<b>Rubber Brake Hoses and Fuel Hoses:</b> Routed correctly. No dry rot, cracks or leakage. Metal brake lines should not have rust or leakage. Check braided steel lines annually.

No warranties or guarantees are implied or expressed by the passing of the inspection performed. I acknowledge that the safe condition and operation of my Car is entirely my responsibility. I take full and sole responsibility for any vehicle problems, malfunctions, or damage that may occur in connection with the operation or performance of my Car prior to, during, or after the Event.

I acknowledge that I am responsible for any Facility damage caused by me and that I shall pay for the damage of any portion of the Facility (structures/track surface/paddock/grass) billed directly by Facility or Region to me at the time of occurrence. Hybrid / Electric vehicle owners shall also be responsible for damages to the Facility caused by any battery combustion.
