Minutes of the Executive Board Meeting

August 17, 2014

The Executive Board of Riesentöter Region, Porsche club of America, Inc. held a meeting on Sunday, August 17, 2014 at the Reading Phillies in Reading, PA. A special thanks goes out to Kris Haver for our venue. The voting members present in person were Jeffrey Walton, David Newton, Paula Gavin, Wendy Walton, Chris Barone, Marty Kocse, and David Nettleton, constituting a quorum. The voting members absent were Joe Asher, Chris Karras, and David Hathaway. Acting as Secretary, was Chris Barone. Another note of thanks goes to Chris Barone and David Nettleton coming directly from Street Survival in order to constitute a quorum.

Jeff Walton welcomed the board members at 5:30pm and called the meeting to order.

David Newton moved the adoption of the minutes of the Board Meeting held July 13, 2014, which were distributed to the Board in advance of the meeting. Jeff Walton seconded the motion and the minutes were approved unanimously.

David Newton updated the board that the next membership meeting was on Wednesday August 20, 2014 at Possum Hollow in Phoenixville with a special guest speaker from Castrol. The September membership meeting will be a breakfast meeting held at Wyebrook Farm on Saturday September 27, 2014 starting at 9am. She also noted an Ice Cream Happy Hour for the family will be held on Tuesday August 26 at the Milky Way Farm in Chester Springs.

Paula Gavin announced we had 17 new members join in July.

Kris Haver said she wanted to get the names of the 2014 award winners as soon as possible and wanted all the names by the next executive meeting. The board informed her that October will be better as to most of the club activities are starting to wind down. David Nettleton informed us his last race is in Hershey on Nov 9<sup>th</sup> and since standings are very close he will not have a winner until a few days after that.
